Deep Web Searching – What Does That Mean?

Static Web Page (Surface Web)	Dynamic Web Page (Deep Web)
Written by a human being	Written by a computer drawing from a database
Doesn't change unless a human being rewrites the text -- static	A new page is generated by a computer with each new query, and the same query will deliver different results if the database has been updated -- dynamic
Always there unless the website manager deletes it	Goes away when the browser window closes
URL is usually fairly simple, with no strange characters – just slashes and dots	URL often has strange symbols like percent signs and question marks
Usually visible via a Google search	Often invisible to Google


