AskColorado: Virtual Reference Service

AskColorado (<a href="http://www.askcolorado.org/">http://www.askcolorado.org/</a>) is a free virtual reference service provided by Colorado libraries. In the second year of a pilot program run by the Colorado State Library, AskColorado offers 24/7 live chat interactions with reference librarians including special features such as Live Homework Help and Spanish speaking librarians.

The service is funded by librarians from 53 public, school, academic and special libraries as well as money from a Library Services Technology Act (LSTA) grant. Approximately 200 librarians staff the online, live chat lines. Early morning / late night hours and specialized services are provided by Tutor.com personnel. The current funding and staffing requirements for individual libraries varies based on the size of the library. The Program Coordinator, Sharon Morris, is responsible for scheduling and training staff as well as coordinating other aspects of the project.

Reference librarians work with the patrons in a co-browsing environment, demonstrating their search techniques and pushing web pages directly to their browser. The patron also receives a complete transcript of the session with embedded urls so that they will have a record of the resources that were used in the session. In addition to this live chat experience, several special libraries are available for email referrals. These libraries include the University of Denver Law Library, the National Indian Law Library, CU Health Sciences, and the State Government Publications Library. AskColorado has been an overwhelming success. In the first year of operation, the service answered over 23,000 calls, more than double the number projected in the grant application. In the first quarter of year two (September – November 2004), AskColorado received an additional 9,287 requests.

In addition to these usage statistics, AskColorado won the 2004 Project of the Year Award by the Colorado Association of Libraries, was awarded the 2004 Exemplary Service Award from Virtual Reference Desk and was the recipient of the 2004 Most Innovative Marketing Award from Tutor.com.

AskColorado has been in the news since it's debut in September 2003 with numerous newspaper articles, press releases and even TV coverage. The AskColorado service is prominently displayed on the Colorado State Government webpage (see featured sites) as well as the Colorado Virtual Library interface. On Dec. 3, 2004, Colorado Public Radio rebroadcast a 10 minute interview with Brenda Bailey-Hainer, Director of Networking and Resource Sharing at the Colorado State Library <a href="http://www.cpr.org/cgi-bin/comatters/com\_day.cgi?date=12/3/2004">http://www.cpr.org/cgi-bin/comatters/com\_day.cgi?date=12/3/2004</a> (originally broadcast in 2003).

David Selden, National Indian Law Library is a member of the Colorado Virtual Reference Steering Committee which oversees the project. Although NILL hasn't had any questions on tribal law, the University of Denver has answered approximately 50 referral questions in 2004. These questions vary widely in topic and depth as well as type of patron. Questions are answered using a variety of Internet legal research sites, as well as referrals to particular books or other printed materials as needed. In addition, replies contain a disclaimer about not being allowed to give legal advice and often include referrals to self-help or free/low cost attorney services in Colorado.

#### Keep It "Simple"

Do you find it increasingly difficult to keep on the latest happenings in the world of law, politics, and possibly technology? The evolution of "current awareness" on the Internet has taken a giant leap in recent months with the mainstreaming of the web log, or blog, or blawg.

Previously, you could read the newspaper, listen to the radio, or perhaps watch television news on the local stations. Cable television upped the ante, but also made the choices more difficult. You have ABC, CBS, NBC, CNN, CNNH, MSNBC, CNBC, Fox, Fox News Channel, and some people even profess to keep current on the news by watching *The Daily Show* on the Comedy Channel. Attorneys can also relax in front of CourtTV and watch live trials. The Internet made it even easier to keep current. One could subscribe to mailing lists or listservs®, surf news sites, or access legal portals like FindLaw, MegaLaw, or law.com. The web log has now changed the way I keep current on a variety of things. In essence, I've had an epiphany, and its name is "blog."

First things first. Blog is simply the shortened term for web log. Blawg is short-hand for a web log that is law-oriented. The "simple" referred to in the title of this article is part of the term "Really Simple Syndication," or even more simply, RSS. RSS is an XML-based (Xtensible Markup Language) format for content distribution. It's a news feed, similar to what would come across a teletype (do those still exist?) from the Associated Press or United Press International in the days of yore. The great thing about all of this is that you need to know absolutely nothing about RSS, XML, or any other portion of the alphabet soup associated with it. A nice page offered by the web site c|net explains a lot of this, if you are interested. http://www.cnet.com/4520-6022-5115113.html

One thing you will need is a news aggregator, and a little time to subscribe to your feeds. The aggregator I started using after my epiphany is Bloglines. http://www.bloglines.com

You must sign up for the service, usually with just an e-mail address and password. After you do that, you're ready to go.

How do you subscribe to newsfeeds? If you use Bloglines, they offer a list of blogs that you want to use. The other way is to surf over to the web site associated with the blog. Before doing that however, you want to load a little "bookmarklet" that allows easy subscriptions to blogs without any hassle. There will be a link to it on the Bloglines page. It will direct you to drag the bookmarklet to your Links toolbar. This can be done by those using either the Internet Explorer or Mozilla Firefox web browsers. Trust me, it's *easy*. Next, find a web log, any web log. You might have seen one referenced on a web page or a newspaper story. Doesn't matter. You might also use a web log search mechanism like **http://blawgs.detod.com/** to help in finding a relevant one. One you can use for practice is Robert Ambrogi's LawSites, located at **http://www.legaline.com/lawsites.html**. You will see one of these symbols:

XML or RSS

That means that there is a feed available. What you should then do is click on your Bloglines subscribe bookmarklet and the subscription process begins. If that doesn't work, you may have to click on the XML or RSS icons first, then the bookmarklet.

Here is what your Bloglines subscription frame will look like once you've subscribe to a few things:

All of the above blawgs cover some aspect of the law, whether it's legal research, appellate practice, or the U.S. Supreme Court. It's a

great way to keep current on a myriad of subjects.

There are literally thousands of web logs out there, perhaps millions. Some are good, some are garbage. You should discern the reliability of a blog on your own or rely on a trusted opinion. You can use a different news aggregator other than Bloglines, it's just the one I chose to

use for illustrative purposes. If you need help with any of this RSS stuff, please send me an email and I'll be glad to offer some tips.

#### 1. Call to Order

✓ President Dan Cordova called the meeting to order at 4:05 PM.

#### 2. Introductions/Recognition of Guests

✓ Goldie gave a CoALL members count: 61 current, paid members

#### 3. Announcements

#### **Secretary of State filing**

- ✓ Dan reported that Katheryn Christnacht has been taking care of the SOS filing for the Association. She is getting legal assistance from an attorney at HRO.
- ✓ It has been clarified that this filing is done every year, but a filing fee is due every other year.
- ✓ This year's filing will reflect the Association's shift from a 501(c)(6) [trade association] to a 501(c)(3) [educational association]. This shift will allow for tax-deductible donations to the association, as well as assist with the streamlining of programming, training, and educational activities outside the confines of CoALL.

#### Chapter liability insurance

✓ Insurance costs \$1.50/employee, done through AALL. Payment is due by the end of October.

#### 4. Committee Reports

#### **Kaye:** Holiday party

- ✓ Dan has recommended the holiday party be held at Ardelt's (<a href="http://www.ardeltsvictoriangarden.com/">http://www.ardeltsvictoriangarden.com/</a>). This facility will accommodate approximately 50 sitting/100 standing, plus there is room for overflow. Kaye is verifying that the cost for three hours would be \$300 (or \$400 or 4 hours, to allow for setup and cleanup). This cost will include the sound system and decorations.
- ✓ Dan also has a caterer he recommends. He will negotiate a price, but Board is aiming for approximately 50 people @ \$12 each. It is also budgeting for around 12 bottles of wine @ \$7 each. Holly Kulikowski will help with this.
- ✓ Tentative holiday party date: December  $9^{th}$ , 6 9:00 PM
- ✓ Once location and date have been verified, it was suggested a "save the date"/pre-RSVP announcement go out

✓ Holiday party is traditionally a venue to introduce new members

#### **Programming**

- ✓ Board meeting will be set for November to discuss organizing a BRAG or Institute session for the spring as well as what other programming needs to take place outside of BRAG or the Institute.
- ✓ Kaye mentioned SLA's annual meeting in 2007 will be in Denver. She suggests CoALL organizing a presentation for the event.
- ✓ Ann-Marie suggested personal invites to CoALL meetings, namely by phone. She volunteered to coordinate the effort.
- ✓ Dan reported that the deadline to request a chapter visit from an AALL member has passed so there will not be a chapter visit in April 2005.

✓ No new Treasurer's Report was submitted; not necessary at this time

#### 6. New Business

#### **Prez Group**

✓ Dan let the Association know of the current status of Gail Dow as head of the Prez Group. The Prez Group is an informal group involving the presidents of local chapters, getting together to share ideas and marketing strategies. One of the consequences of CoALL shifting to a 501(c)(3) is that there cannot be any involvement in PACs. The future of Gail Dow as head, as well as CoALL's participation in the Group, is uncertain.

#### PR Chair

- ✓ Monica Martens cannot continue in this position and so a successor is being sought.
- ✓ Job description (as provided by Monica):
  - 1. When I hear of a CoALL program / event or read of news (about CoALL or a member) in our newsletter, then I create a blurb about the item and send it to a contact person at AALL for publication in Spectrum.
  - \*\* Karen Selden who did this position previously was also very good about sending information to various groups within CoALL -- newsletters for the SIS's and SWALL, for instance. I did this the first year and then couldn't get to it all.

- 2. Last year I submitted us for an award, which required putting together an application.
- 3. I attend the PR meetings at AALL. Usually lasts one hour on one of the days of the annual meeting.
- 4. In the past I organized PBS volunteering, but last year we decided to take a break from this; we just didn't have the member interest, and the perks in terms of getting our name out weren't as good as they were when we first started doing this. Plus, it sounded like the PR position might be used more to publicize CoALL events within the community.

I haven't been involved in local PR, though. Mostly, I think, organizers of CoALL events get the word out themselves.

- ✓ Theresa Baker has been offered the position of Web Master for CoALL.
